As such, there is currently no emissions data to baseline and report on total scope 3 emissions. We will work with our advisors to cover these emissions and create a credible scope 3 baseline for 2024.



Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 30 tCO $_2$ e by 2028. This is a reduction of 20%

Reed Medical Limited will continue to record annual emissions arising from our premises and vehicles and continually improve our process for doing so. For 2024 we will also target and report on the other relevant scope 3 emissions, now in scope, by working closely with our advisors.

Reed Medical Limited will plan future investment to ensure efficiencies are achieved. The premises already benefit from solar panels and seeking to install LED lighting. Consideration will also be given to future replacement of company vehicles with electric cars.
